LOCATION

The property occupies a prime position at the junction of Vicar Lane and Fish Street close to the Victoria Quarter. Nearby occupiers include Greggs Bakery, Boots the Chemist, William Hill, French Connection and Leeds City Market is on the opposite side of the road.

DESCRIPTION

The property comprises a ground floor shop with A2 use together with basement storage and two upper floors.
